On the grounds of Cl. 5. Par.1. It. 21 of the Minister of Finance Regulation dated 19 February 2009 on current and periodic information conveyed by issuers of securities and conditions of recognizing as equivalent information requested by legal regulations of a country that is not a member country (*Dz.U. z 2009r, Nr 33, poz.259*), the Management Board of KOPEX S.A. with registered seat in Katowice (the Issuer) has been aware of receiving today information that Mr. Krzysztof Jedrzejewski- Vice President

of the Issuer's Management Board has submitted his declaration in writing to the Supervisory Board

for resignation from the post of the Vice President of the Management Board of KOPEX S.A.

No reason to resign was included in the declaration in question.

At the same time, on the grounds of Cl. 5. Par.1. It. 22 of the Minister of Finance Regulation dated 19

February 2009, the Issuer's Management Board informs on appointment of a managing person.

Today the Supervisory Board of KOPEX S.A. has adopted a resolution No 53/VI/2009 on appointment

of Mr. Józef Wolski to the post of Vice President of the Management Board of KOPEX S.A. in charge

for financial management, starting from 01 October 2009.

Alterations in the Issuer's Management Board are designed for subsequent rationalisation of

managing the KOPEX Capital Group by dividing financial function from strategic supervision over the

whole Group; the both functions were exercised by Mr. Krzysztof Jedrzejewski previously.

We also inform that the shareholders will be proposed to vote for a resolution on appointment of Mr.

Krzysztof Jędrzejewski to a member of the Issuer's Supervisory Board at the next General Meeting of

Shareholders of KOPEX S.A., where he is going to exercise control on execution of the development

strategy of the KOPEX Capital Group.

He is not a participant of a competitive company as a partner in a civil partnership, a partnership, as a member of the body of a capital company or of any other competitive legal person as a member of its body.
