Contents of the report:

Management Board of KOPEX S.A. with a registered seat in Katowice (the Issuer) informs that on 19 April 2010 has received a written resignation during the term of office by Mr. Damian Jędrzejewski (father of Mr. Krzysztof Jędrzejewski, the majorty shareholder of KOPEX S.A.) - member of the Supervisory Board of KOPEX S.A since 30.12.2008.

Management Board of the Issuer informs simultaneously that today has received a document from Mr. Krzysztof Jędrzejewski – majority shareholder of KOPEX S.A., holding 44.050.175 Issuer's shares which represents 59,26% of the total shares and votes at the general meeting of KOPEX S.A. In connection with the avbove mentioned resignation and under the provisions of § 35 of the Issuer's Statute of Association Mr. Krzysztof Jędrzejewski has appointed a new member of the Supervisory Board in the person of Mr. Artur Kucharski, to complement its five-composition.

Pursuant to § 28 of the Minister of Finance Regulation dated 19 February 2009 on current and periodic information (...) and in connection with the adopted by the Company rules of corporate governance, in particular rules contained in part three "Best Practice Rules for members of the supervisory boards", the Issuer informs ,on the basis of declarations received from a new member of the Supervisory Board, as follows:
