Subject: Significant agreement concluded by the Issuer's subsidiary ZZM – Maszyny Górnicze sp. z o.o. with Kompania Weglowa SA

Legal basis: Law on Offer, Art. 56, Par.1 Item 2 – current and cyclic information

#### Contents of the report:

The Management Board of KOPEX SA with its registered seat in Katowice (the Issuer) informs that today has been aware of receiving by ZZM – Maszyny Górnicze sp. z o.o. with its registered seat in Zabrze (the Issuer's indirect subsidiary) an agreement signed with Kompania Węglowa SA based in Katowice.

The Parties of the aforementioned agreement dated 30.01.2013 are: ZZM – Maszyny Górnicze sp. z o.o. based in Zabrze – Lessor and Kompania Węglowa SA – Lessee.

The subject of the agreement is "Lease of the longwall shearer together with full warranty and service support during the whole term of a lease for KW SA, Bolesław Śmiały Coal Mine".

Value of the agreement: PLN 3,501,479.68 + VAT

Term of the agreement: 688 days, with the possibility of shortening for 120 days

## Stipulated penalties:

Each Party is obliged to pay the other Party stipulated penalties amounting to 10% of the net value of the agreement in case of renouncing the agreement by any Party due to the reasons caused by that Party.

The criterion of recognising an agreement as a significant one is exceeding by it of 10% of bounds pertaining to the Issuer's equity capital (the Issuer's equity capital amounts to 1,350,333 thou PLN, in compliance with data included in the published report for the thrid quarter of 2012) and fulfillment of the criteria set forth in Par.2 Cl.1 Item 44) and Par.2 Cl.2 of Regulation of the Minister of Finance dated 19 February 2009 on current and periodic information (...). In the past 12 months the Issuer's subsidiaries signed with this customer and its subsidiaries agreements amounting altogether to 154,454 thou PLN (including this one). The Issuer informed about the last agreement with this customer in the current report RB12/2013 dated 7.02.2013. The highest value agreement from among all the agreements signed in the past 12 months is the agreement the Issuer informed about in the current report RB 82/2012 dated 25.05.2012 that also includes information relating to the highest value agreement set forth in Cl.9 Items from 1) to 7) of the Minister of Finance Regulation dated 19 February 2009 on current and periodic information (...).
